FREQUENT PLAYER PASS – BLAIRWOOD & LTC

PASS IS GOOD FOR THE FOLLOWING AT BOTH BLAIRWOOD & LTC:

- Any walk-on court time.
- Reserved court time – reservations limited to 7 days in advance.
- Up to 2 hours of court time per day.
- 1 hour of ball machine per day.
- Member must be in good standing to purchase a pass.
- Club reserves the right to revoke the pass if misused.
- Pass not valid toward Permanent Court Time, tournaments, River City or USTA practices and/or matches.
- Court must be cancelled 24 hours in advance or you will be charged regular court fee.
- If playing with a Junior member, pass holder can only reserve court time 2 hours in advance for Junior member to play free.
